In the event Farwest Corrosion Control Company determines the information contained in this credit application is false or misleading of any kind or nature, Farwest Corrosion Control Company may without further notice, cancel any orders in house or any deliveries in progress to applicant. Any false or misleading information by applicant shall be construed as a material default, and any invoices outstanding shall become immediately due and payable in full.

This agreement has been entered into in the City of Downey, in the County of Los Angeles, State of California and any action brought hereunder shall be brought in said County and State at the option of and at the sole discretion of the creditor.

Applicant hereby authorizes Farwest Corrosion Control Company to contact any and all banks, credit references and/or trade references listed herein and further authorizes said banks, credit references and/or trade references to provide information requested by Farwest Corrosion Control Company in order to evaluate this application.
